




Summary/Highlights: On May 21, 2009, county council awarded lawn maintenance for Zones 1-4 to Helping Hand Lawn Care, Sorrento, Florida. On July 29, 2009, Helping Hand notified the county that they are going out of business. Using departments met to review the next lowest responsible vendors. Staff recommends that council cancel the agreement with Helping Hand lawn care and award to the next low responsive and responsible bidder in each zone as follows: Central Florida Bobcat, DeLand, Florida, zones 1 and 4; Midstate Lawnscape, Enterprise, Florida, zone 2, and JEM Enterprises, Deltona, Florida, zone 3. Price agreements will be issued for three years with two one year renewal options.
