- Re-entry Job Fair on-site August 21st lead by Port Orange South Daytona Chamber of Commerce and Council Reinhart.
 - o 7 employers participated
 - o 23 sentenced inmates scheduled to be released in September
 - o Inaugural with plans to provide quarterly

- Awarded 500K Opioid abatement grant for MATs program scheduled for approval at the September 17th council meeting.
